5. Former Contestants may participate again as long as they meet Rules 3 & 4
6. Contestants may have a local sponsor
(Local Business or Organization)
7. Contestants will pay a \$40.00 entrance fee. This fee includes your Creator. Please make checks or money orders payable to ISEA, Inc

11. Only your Creator is allowed in the Contestant Dressing Area
(NO OTHER ASSISTANTS WILL BE ALLOWED)
12. Your Creator will only have One Hour to transform you from your Birth Gender the Opposite Gender
(Male to Drag Queen; Female to Drag King)
13. Contestants will be judged in the following categories:
Birth Gender Presentation: 30 pts per judge
Originality (10) + Costuming (10) + Presence (10) = (30)
Transformation: 100 pts per judge
Transformation (50) + Originality (15) + Costuming (15) + Presence (20) = (100)
Entertainment: 70 pts per judge
Originality (20) + Costuming (20) + Presence (30) = (70)
