# ATTACHMENT FOR: TYRA MARIE HISPANIC SCHOLARSHIP

# **Background**

As a proud Hispanic and first-generation college graduate, Isak aka "Tyra Marie" understands the value and importance education has played in all facets of his life. The power of education has opened many doors for him and because of this Isak has a strong desire to share that experience with his fellow Hispanic community. Over the past several years, enrollment amongst Hispanic students in colleges has increased significantly largely due to the availability of scholarships and financial assistance. In order to help encourage and continue this trend, the Tyra Marie Hispanic Scholarship Fund has been created.

### **Applying for the Scholarship**

The Tyra Marie Hispanic Scholarship was established in hopes of encouraging his/her fellow Hispanic community to pursue their dreams. The scholarship fund will award two (2) \$2,500 scholarships to students of Hispanic descent who demonstrate strong academic records and financial need and plan to pursue their undergraduate or graduate degree at an accredited U.S. college or university.

#### To be eligible for the Scholarship, you must:

- Be a United States citizen or permanent resident of the United States and resident of the State of Arizona for the past 365 days. (If permanent resident, please attach a copy of your residency card).
- Must be of Hispanic descent.
- Include a copy of your most recent 2017-2018 financial aid award letter from your educational institution.
- Show evidence of community involvement (i.e. school, church, civic, LGBT, etc.)
- A self-identified gay, lesbian, bisexual, transgendered or straight ally (showing support of LGBT youth and/or the LGBT community).
- Plan to apply to attend (or are currently attending) a post-secondary educational institution.
- Provide a current high school and/or college transcript (or GED).
- Have a cumulative GPA of 3.5 or higher (or GED).
- Attach two (2) letters of recommendation from individuals who know of your ability to be successful in your chosen field of study. Relatives cannot submit these letters.
- Submit a completed Tyra Marie Hispanic Scholarship Fund application and supporting documents.



# ATTACHMENT FOR: THE BROADWAY GATLYN SPECTRUM GRANT

### **Background**

Medical transition is not just a desire for several transgender individuals, it is also a necessary step for individuals to feel whole; to feel like their authentic self. Gender affirmation surgeries are continuing to be a tough subject when it comes to health insurance and medical necessity. While some companies and insurance carriers do cover medical expenses associated with transitioning, an overwhelming majority don't. This leaves transgender individuals with an overwhelming task of funding their surgeries themselves. For a lot of transgender individuals, this can be next to impossible. Through the efforts of the Imperial Court of Arizona; we want to make it possible for transgender individuals to become their authentic self but alleviating the burden of the costs associated with gender affirmation surgery.

### **Applying for the Grant-**

This grant was developed to assist Arizona transgender individuals with gender affirmation surgeries. This grant will award one individual \$5000 towards their gender affirmation surgery. The recipient will show a financial need, their active diligence in following the WPATH standards of care, active involvement in raising the needed money, active participation in organizing/scheduling their medical transition, and show active involvement in their community.

- Be a United States citizen or permanent resident of the United States and resident of the State of Arizona for the past 365 days. (If permanent resident, please attach a copy of your residency card).
- Have a surgeon picked out and either a consultation scheduled or your plans to schedule this. Have surgery letters by physician and/or licensed therapist.
  - If applicant has not completed all of these steps, but is planning to do so, please include your plans in your application.
- Identify who will care for and provide support post-surgery.
- Applicant must demonstrate a need for financial assistance.
- Applicant must detail the efforts they have made to fund-raise and the amount of cost that they will be able to cover on their own, if any.
- Applicant must show evidence of community involvement (i.e. school, church, civic, LGBT, etc.)
- The payment will be made directly to the doctor or hospital facility. You must comply with any and all
  requirements according to the Standards of Care of the World Professional Association for Transgender
  Health's (WPATH) as determined by your selected surgeon.
